The Child Sponsorship Program is designed to offer the members and friends of the Apostolic Christian Church an opportunity to be directly involved in the lives of children that are born in economically distressed areas of the world.

Many have seen the needs of the children in Haiti, Jamaica, and Mexico through World Relief slide presentations or experienced them first-hand while serving on a work team. Now, for a small monthly donation, a sponsor can help a child receive a Christian education which enables him to read the Word for himself to learn about salvation. As the Gospel bears fruit in his life, he also will have the tools to share it with others.

Gift Policy: Sponsorship donations do not include gifts for birthday and Christmas. Additional monetary gifts for such occasions must be specified on the check. Gift money is not tax deductible. It is recommended that gifts not exceed \$20.

Correspondence: All correspondence between sponsor and child must go through the Apostolic Christian World Relief Child Sponsorship office. Sponsors will receive pictures and letters periodically.

Prayer: Sponsors and children are encouraged to pray for one another.

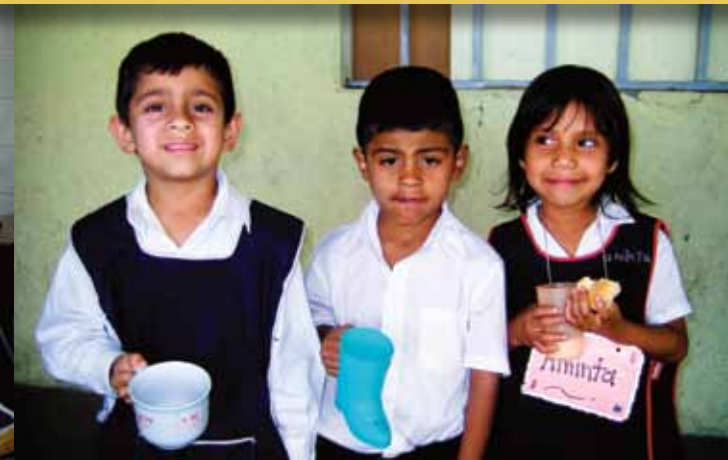

Schools in the country of Haiti offer the option to sponsor individual children or an entire school. Haitian parents often go without food in an attempt to pay for their children's education. The only hope these parents have is for one of their children to be educated so that child can be a help to the family and support the parents in their old age.

CHILD SPONSORSHIP

Donation per child: \$25.00-\$35.00 per month

Cost varies depending on the child's grade level.

Your donation provides the following for the child:

- Uniforms to wear to school
- School materials
- Teacher salary subsidy
- Food for the child's family

Note: The cost for trade school and university students is dependent on where they attend. If you have an interest in this area, please send a note with your reply card.

SCHOOL SPONSORSHIP

Donation per school: \$1,320.00 annually

Your donation provides the following:

- Sponsors an entire primary school
- Subsidizes salaries for 5-10 teachers
- Only schools without sponsored children are eligible for school sponsorship

In the country of Jamaica the sponsorship program is for individual deaf students only. Jamaica is not set up for sponsoring an entire school.

Jamaica has an estimated 2500 deaf children. Although the Gospel is available in Jamaica, a deaf person cannot hear the Gospel. The Gospel is presented to deaf children using Sign Language through this program.

CHILD SPONSORSHIP

Donation per child: \$25.00 per month

Each child may have up to 10 sponsors, to make up the full sponsorship cost of \$250 per month, which includes room and board.

Your donation provides the following for the child:

- Housing on campus at the Caribbean Christian School for the Deaf (children board at the school)
- Clothing for the child
- Medical care
- Food
- Training and education during the school year

From your donation, the child will:

- Receive a Christian education
- Learn to communicate through sign language
- Receive training to eventually become proficient in a trade

The sponsorship in Mexico offers the opportunity to sponsor an individual student or to contribute to a class sponsorship at the same cost as an individual student.

At the Isaiah 55 ministry in Reynosa, the sponsorship is for deaf children with each class assigned 5 sponsors.

The goal of sponsorship is to steer these children from lives of crime and sin to lives filled with the hope of Christ.

These children are so appreciative of the chance to learn a core academic curriculum and also the word of God.
